Ni iki kiri kuba?

- Muri Kamena 2025, Perezida Trump yategetse ko abaturage bo mu bihugu 19 babuzwa kubona viza zo kwinjira muri Amerika, avuga ko zishyira mu kaga umutekano w'igihugu cya Amerika. Mu Kuboza 2025, yaguye urutonde rw'ibihugu byabujijwe ingendo bigera ku bihugu 40.
- Mu Gushyamba 2025, USCIS yategetse ko hafatwa icyemezo cyo guhagarika (<https://immigrationpolicytracking.org/policies/uscis-orders-review-of-all-refugees-admitted-under-biden-administrati-on/#/tab-policy-documents>) ku isuzuma ry'ubusabe bwo guhindura imiterere (amakarita y'icyatsi kibisi) bwatanzwe n'impunzi zose zemerewe hagati ya tariki ya 20 Mutarama 2021, na 20 Gashyantare 2025, kandi yategetse ko isuzuma n'ibiganiri bishobora kongera kubazwa impunzi zose zemerewe muri icyo gihe.

 - kongera gusuzuma ubusabe bw'ubwishingizi bwari bwemewe mbere ku baturage bo mu bihugu bibujijwe ingendo.

- Ubusabe bumwe bushobora kwangwa niba USCIS ibona ko ubwenegihugu bw'usaba buteza ibibazo by'umutekano.
- Abo uburenganzira bwabo bwo gusaba mbere buri gusuzumwa bashobora kwitega ko baganirizwa ku bijyanye n'izo byifuzo cyangwa bagasabwa ibindi bimenyetso byerekana ko bujuje ibisabwa.
- Bamwe bashobora kubona inyungu zabo cyangwa imiterere yabo ihagarikwa cyangwa igakurwaho, kandi bashobora koherezwa mu nkiko ziburukana
